In principle, any reimbursement of your workers' travel expenses for the journey between their home and their place of work constitutes taxable remuneration. However, the Income Tax Code expressly grants an exemption for this income under certain conditions and within certain limits.

Summary of FAIB Lunch-debate of 19 february 2019: "Reform of the legislation on the insolvency of associations"

Alain Costantini, DKW, gave a presentation on the reform of the legislation on the insolvency of (I)NPAs, introduced by the Act of 11 August 2017. This Act is integrated in the Belgian Code of Economic Law and constitutes its Book XX, called "insolvency of undertakings". It entered into force on 1 May 2018.
