3. RELATIONS WITH THE FEDERAL & REGIONAL AUTHORITIES

As in previous years, regular follow-up with the Federal authorities - in particular with the cabinets of the Federal Minister for Foreign Affairs and Justice – was given.

The FAIB was actively involved in discussions relating to the Reform of the Companies and Associations Code recently adopted and regularly reports about it in its newsletter. Other lobbying initiatives are envisaged on which the President will report.

Regular contacts were held with various services of the Brussels Capital Region, e.g. Brussels Invest & Export (BIE), Actiris, Expat Welcome Desk, and other official bodies.

The “One-Stop-Shop” that the FAIB has been advocating for several years, namely offering associations wishing to establish or already established in Belgium, a central point of reference that will include essential information for the creation and management of European and International associations has been set up in the meantime by visit.brussels, under the name “Association Bureau”.

It redirects questions from European and international associations to the various bodies involved in the partnership, notably FAIB/UIA/MAI/ESAE in addition to official organisations such as Brussels Invest & Export, Actiris, Impulse and the Expat Welcome Desk of the Commissioner for Europe.

Under this agreement, the Practical Guide created and regularly updated by the FAIB with the help of its associate members will be the primary reference for associations wanting to establish in Belgium/ Brussels Region. FAIB continues to collaborate to the organisation of the “European Association Summit” by visit.brussels that took place this year on 10-11 March 2020. The session managed by FAIB focussed on the [GDPR in Action - Learning from two years and going forward](#) – giving the floor to two FAIB Associate members and the representative of “Kom op tegen kanker” who presented the main features of the issue. The presentation is available on FAIB’s website.

The FAIB also contributes to initiatives developed by the management of the Foundation “MAI” in view of providing international associations with a “home” at the level of their expectations and suitable meeting space.

FAIB is also represented in the Council of the Union of International Associations.

5. FAIB WEBSITE

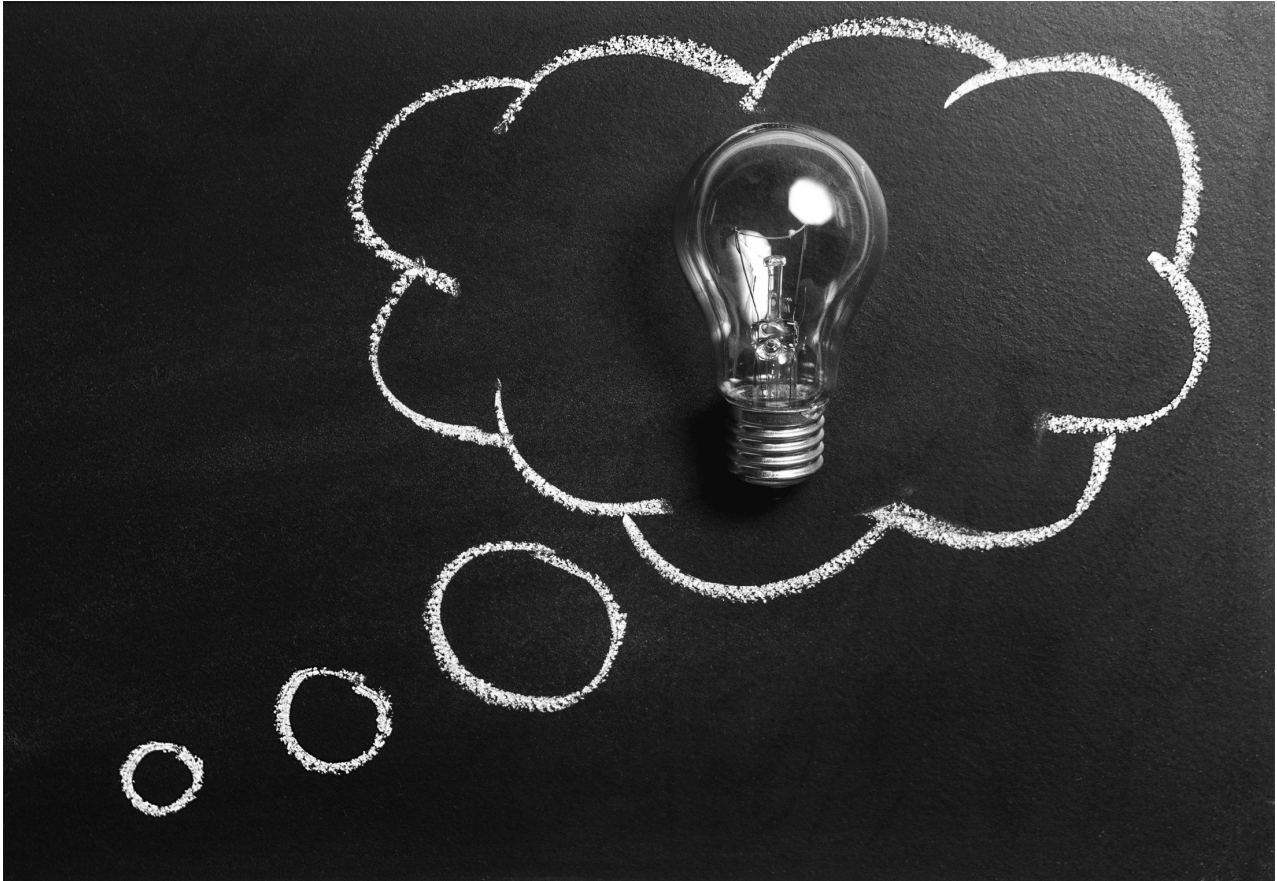
